Note:

1. The above staff may be advised to exercise their option if any for fixation to next higher grade within one month from the date of issue of this office order In terms of RBE No. 103/2008 and RBE No. 132/2008.
2. The above financial up-gradation under MACP scheme is purely personal to the employee and shall have no relevance to his seniority position.
3. There shall be no change in designation, classification or higher status. However financial and certain other benefits which are linked to the pay drawn by the employee such as HBA, allotment of Government accommodations shall be permitted.
4. In terms of RBE No.113/2017 benefit of pay fixation at the time of regular promotion shall also be allowed at the time of financial up-gradation under the scheme. There shall however be no further fixation of pay at the time of regular promotion, if it is in the same grade pay as granted under MACPS. At the time of regular promotion to higher grade pay than what has been given under MACPS, the employee shall have the option to draw the difference of grade pay from the date of such regular promotion of non-functional scale or the date of accrual of next increment in the pay allowed under MACP.


