- 2) The above staff may be advised to exercise their options, if any, for fixation of pay as per extant rules within one month from the date of issue of this office order.
- 3) The above financial up-gradation under MACP scheme is purely personal to the employee and shall have no relevance to their seniority position.
- 4) There shall be no change in designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by the employee such as HBA, allotment of Government accommodation shall be permitted.


- 5) Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up gradation under the scheme. Therefore, the pay shall be raised by 3% of the total pay in the Pay Band and the Grade Pay drawn before such up-gradation. However, there shall, be no further fixation of pay at the time of regular promotion if it is in the same Grade Pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.
