The following transfer, promotion and posting orders are issued provisionally with the approval of competent authority to have immediate effect.

Sri Tarapada Jana, General Asst, CH/MCS, who was allotted to combined cadre of GA/Pers/Med deptt. of /HQ/BBS for provisional promotion and posting as Jr.Clerk-cum-typist, is posted as Jr.Clerk-cum-typist in Level-2 at CH/MCS vice Sri Subhashis Mallik, Jr.Clerk-cum-typist to be transferred to the office of PCPO's/BBS.
2. Sri Parsu Kumra, Office Asst/PCPO's Office/BBS who was allotted to combined cadre of GA/Pers/Med deptt. of /HQ/BBS for ad-hoc promotion and posting as Jr.Clerk-cum-typist, is posted as ad-hoc Jr.Clerk-cum-typist in Level-2 in Stores section of PCPO's office/BBS.
3. Sri Sanjit Kumar Jena, Genral Asst/PCME's Office/BBS who was allotted to combined cadre of GA/Pers/Med deptt. of /HQ/BBS for ad-hoc promotion and posting as Jr.Clerk-cum-typist, is posted as ad-hoc Jr.Clerk-cum-typist in Level-2 in Bills section of PCPO's office/BBS.


NB: (i) Sri Subhashis Mallik, Jr.Clerk-cum-typist may be released immediately to report at PCPO Office/BBS for futher posting.

- (ii) The staff under Sl.No.01 is required to pass the Typewriting Test within two years from the date of his provisional promotion as Jr. Clerk-cum-Typist or else he is liable to be reverted to former substantive post.
- (iii) The seniority of the employee at Sl.No.01 will be maintained as Jr.Clerk-cum-typist in the combined ministerial cadre of GA/Pers/Med of HQ/BBS & WPO/MCS subject to his passing typing proficiency test.
- (iv) The promotion of the above named staff are provisional subject to clearance of SPE/Vig/DAR cases/punishment on the date of promotion.
- (v) The staff at Sl.No.02 & Sl.No.03 are promoted on ad-hoc basis for a period of six months on "best among failed Scheme "against the available reserved vacancies. At the end of six month period a special report should be prepared on the working of these staff and the case to be put up by the department concerned to personnel branch for review. The continuance of the said staff as Jr.Clerk-cum-typist will depend upon review and if they are found to have come upto requisite standard, their names are to be included in the panel otherwise their names should not be included in the panel.
- (vi) The ad-hoc promotions of staff at Sl.No.02 & Sl.No.3 are purely provisional and it does not confer on them any claim for seniority, regularization, confirmation or continuance as such beyond six months.
- (vii) The staff at Sl.No.01 may opt for fixation of pay in the promotional grade, within one month from the date of shouldering higher responsibility in terms of the instructions contained in RBE No.79/2017, and amendments issued from time to time.


