NOTE:-

- 1) The above technical resignation has been accepted with the approval of Dy.CE/Planning as requested by Sri Subrat Kumar Sahoo, Trainee JE/DD&E vide his application dated 19.04.2021.
- 2) The Technical resignation in favour of the above employee shall be regulated as per para 1404, 1406, 1410 of Indian Railway Estt.Manual Vol-I.
- 3) The above named trainee should surrender Railway property i.e Railway Quarter, CUG, Electrical fittings, Identity Card etc., if any under his possession and handover charges positively.
- 4) His date of appointment 17.03.2020 & he has not completed 5 (five) years Railway service. As such he has to work for the remaining bond period in the department of Water Resources of Govt.of Odisha. He has to submit fresh bond in the new organisation to serve the balance period as per extant rule.
- 5) Retention of lien does not arise as the trainee concerned has not regularized in permanent post & does not holds substantive post. He will sever his connection with the Railways before joining in Govt. of Odisha.
