NOTE:-

- 1) The above technical resignation has been accepted with the approval of Dy.CE/TP as requested by Manjulata Behera, SSE/P.Way vide her application dated 26.04.2021.
- 2) The Technical resignation in favour of the above employee shall be regulated as per para 1404,1405, 1406, 1410 of Indian Railway Estt.Manual Vol-I.
- 3) The above named trainee should surrender Railway property i.e Railway Quarter, CUG, Electrical fittings, Identity Card etc., if any under his possession and handover charges positively.
- 4) Her date of regularisation as JE/P.Way is 18.10.2016 & she has not completed 5 (five) years Railway service. As such she has to work for the remaining bond period in the department of Works of Govt.of Odisha. She has to submit fresh bond in the new organisation to serve the balance period as per extant rule.
- 5) Retention of her lien will be for 02 years and after that she will sever her connection with the Railways.
- 6) She is free from SPE/Vig & D&A cases.
