3. The above engagement on contract basis in Railways will have no claim or right for continuance or automatic extension of the terms of contract or regularization etc.
4. The contract may also be terminated at any time during the contract period by giving 15 days notice from either side without assigning any reason thereof.
5. Unsatisfactory performance, mentally or physically incapacitation for the service may be debarred him/her to continue and make him/her liable for termination at short notice.
6. The emoluments will be admissible as per Board's letter No. 2017/Trans/01/Policy/Pt.1 dated 12.04.2018 with basic minimum pay in respective pay levels of 7th PC plus admissible allowances.
