

Performance of Personnel department from April'2020 to March'2021:

1. Selection/Suitability/Trade Test:

- (i) **Finalized = 51 categories**
- (ii) Total 1036 staff of Sambalpur Division have been promoted (S&T=01, Electrical(G)=08, Civil Engg.=302, Mechanical=11, Elect(OP)=510, Operating=173, Commercial=24, Personnel=05 and GA=02 staff).


2. RRB panels received:

- (i) Out of **736** panels of ALPs received earlier, 05 panels returned to KUR Division/ECoR & 05 panels deleted as per advice of HQ. From the rest **726** panels, **711** candidates have reported out of which, 227 candidates have been regularized, 55 candidates are under LR/Field training after receipt of PVR, 10 candidates are waiting for PVR, 02 candidates have resigned from railway service during training period, 04 candidates have resigned before sending for training, candidature of 01 candidate has been cancelled after completion of induction training due to adverse remarks in PVR and 220 candidates are under induction training. Remaining candidates are yet to be sent for induction training. Further, case is under process for replacement panel of non-reporting
- (ii) **Trainee JE(Elect/GS)=03 panels** received in May'2020 & all candidates have been posted for training in the division in the month of July'2020.
- (iii) **Trainee JE(Elect/TRD)=15 panels** received in May'2020 out of which 13 candidates reported and posted for training in the division in the month of July'2020. Further, case is under process for replacement panel for 02 non-reported candidates.
- (iv) **JE(Elect/DD&E)=03 panels** have been received in May'2020. However, the said post was not operated in SBP Division earlier for which 03 Nos. of JE(DD&E) revenue posts of HQ/ECoR/BBS have been temporary transferred to SBP Division/ECoR i.e. to Elect(TRD) Deptt.=02 posts & Elect(G) Deptt.=01 post for operation of RRB panels of JE(Elect/DD&E) for a period of one (01) year or till the finalization of pin-pointing/distribution of post whichever is earlier vide DRM(P)/SBP's Memo No.CADRE/Elect(TRD/G)/16/2020 dtd.21/08/2020. As such, all the 03 candidates reported and posted for training in the division.

3. RRC panels received:

- (i) **Track Maintainer-IV=60 panels** have been received in August'2020 out of which, 55 candidates have reported and posted. Out of 05 non-reported candidates, identification mark of 01 candidate in medical memo has found mismatch and the same has been communicated to HQ. Further, case is under process for replacement for 04 non-reported candidates.
- (ii) **Pointsman-'B'=36(33+3) panels** have been received in August'2020 out of which, 30 candidates have reported from which, 20 candidates have been posted after completion training, 09 candidates are under training and 01 candidate to be sent for training. Further, case is under process for replacement panel for 06 non-reported candidates.
- (iii) **Helper(C&W)=12(8+4) panels** have been received in August'2020 out of which, 08 candidates have reported and posted. Further, case is under process for replacement panel for 04 non-reported candidates.
- (iv) **Helper(Signal)=10 panels** received in August'2020 and all have reported and posted.
- (v) **Helper(Train Lighting)=06 panels** have been received in August'2020 out of which, 04 candidates have reported and posted. Further, case is under process for replacement for 02 non-reported candidates.
