Commercial Circular No. 235(G)/2021.

Sub: Traffic at the Private siding of M/s Gopalpur Ports Limited served by Chatrapur.

Ref: Commercial Circular No. 139(G)/2021 dtd. 12.04.2021 and Circular No 199(G)/2021 dated 09.06.2021.

The Private siding of M/s Gopalpur Ports Limited (Alpha Code- GPLC, Numerical Code- 12121123) was temporarily notified open for traffic vide Commercial Circulars under reference upto 11.07.2021.

In supersession to the Commercial Circulars under reference, now, with the approval of competent authority, the following instructions are issued:

- i) Traffic to / from the GPLC siding (a full rake handling point) will be booked on through distance basis of charging, reckoning the chargeable distance as **Chatrapur (CAP) + 9.87 Km.** (Nine decimal eight seven Km)
- ii) In case, any additional shunting operations are performed by Railway locomotive, necessary Shunting charges shall be levied as per extant rules.
- iii) EOL free time is applicable at the siding.
- iv) The list of permitted inward & outward commodities for the siding is as under:
Inward : All Commodity (except POL).
Outward : All Commodity (except POL)
- v) These instructions will come into **effect from 10.07.2021.**
