

Sub: Notification for filling up MV Driver-III in Level-02 in East Coast Railway/HQ against 50% departmental promotion quota.

Applications are invited from serving permanent railway employees of East Coast Railway for filling up of MV Driver-III in Level-02 in East Coast Railway/HQ on regular basis against 50% departmental promotion quota as per conditions stipulated as under:


1	No of Vacancy	04 (Four) Break up vacancies [UR-02, SC-02 & ST-00]
2	Pay Scale	Level-02
3	Eligibility Conditions	<ol style="list-style-type: none">i. Serving regular employee from the categories of erstwhile Group-D in Level-01 (Except RPF/RPSF Personnel & Accounts Department)ii. Possessing valid driving license (LMV) to drive staff car & elementary knowledge of Motor Mechanics. (The candidate should be able to remove minor defects in vehicle.)iii. Minimum three years regular service in the categories of erstwhile Group-D as on date of notification.iv. Possessing the minimum educational qualification of Matriculation from a recognized Institute/Board.
4	Other Conditions	<ol style="list-style-type: none">a. The MV Driver-III have their own channel of promotion. Hence, those who are selected and posted as MV Driver-III on the basis of this selection should seek their promotion in the HQ cadre only.b. After their posting as MV Driver-III, they will no longer have lien in their old unit or claim for transfer back to their erstwhile cadre/Department/Unit.c. Volunteering staff, who accept these conditions only need to apply.d. The employee selected should be prepared to serve any department of East Coast Railway/HQ



4	Other Conditions	<p>e. Any other provision of IREM or circular issued by Railway Board regarding terms and conditions of MV Driver-III selection inadvertently omitted in this notification should be treated as valid and operative.</p> <p>f. All applications should be submitted through proper channel. Any advance copy submitted directly without forwarding of controlling officer will not be entertained.</p>												
5	Mode of Selection	<p>a. The eligible staff who satisfy the above prescribed conditions of eligibility will be called for selection which will comprise of Trade Test and passing of medical test in the medical category of A-3. The Trade Test should comprise both oral and practical and may include written test wherever considered necessary.</p> <p>b. Eligibility list will be published as per their integrated seniority who fulfills the terms and conditions of this notification.</p> <p>d. 6	How to Apply & Forwarding of Application by Units	<p>a. Willing candidates may submit his/her application in the format at Annexure-I. Applicant should fill up application form after thoroughly reading the eligibility conditions and submit the filled in application form with enclosures of valid driving license through his/her Controlling Officer. Incomplete applications will be summarily rejected. The staff who are working in different unit keeping his/her lien in other units of East Coast Railway should forward his/her application through competent authority of lien unit.</p> <p>b. The Controlling Officers should send the applications so received in response to the notification to the respective Personnel Officer of Division/Unit concerned latest by 17th September' 2021</p> <p>c. The Sr.DPOs/SPOs/APOs should verify the correctness of the particulars furnished by the employee in his/her application and forward the same to PCPO's office/BBS on or before 24th September' 2021 in one bunch with a covering letter and attached list (Eligibility / In-eligibility separately) indicating names of the applicants.</p>												


