**Sub:** Notification for filling up Statistical Inspector-II in Level-06 in East Coast Railway against 100% departmental promotion quota.

The notification was circulated vide this office letter dated-30<sup>th</sup> July' 2021 for filling up of 03 (Three) Statistical Inspector Gr-II in Level-06 (i.e. UR-02, SC-01 & ST-00) of Statistical Department/ECoR. The following were the eligibility criteria;

1. Serving regular employee from the categories of Sr.Clerk in Level-05 (except RPF/RPSF Personnel).
2. Minimum three years regular service in the category of Sr.Clerk as on date of notification.

The last date for submission of application by the applicant was 31<sup>st</sup> August' 2021. However, there is no response against the notification dated-30<sup>th</sup> July' 2021. Hence, competent authority has decided to extend the last date up to another one month.

Therefore, the last date is hereby extended upto **19<sup>th</sup> November' 2021** for submitting the option application by willing candidate to their respective cadre controlling officer. Application received after cutoff date i.e. **19.11.2021** will not be entertained under any circumstances and will be rejected.

The cadre controlling officer will forward the applications to their concerned Personnel Officer/Divisional Officer latest by 26<sup>th</sup> November' 2021. If no application is received by that date i.e. 19.11.2021 then a nil report may be submitted.

The concerned personnel officer will verify the service particulars and forward the application of eligible applicant to PCPO/BBS latest by 03<sup>rd</sup> December' 2021 in a single bunch with an index list of eligible and ineligible applicants.

Therefore, you are requested to kindly circulate it in your unit among the staff, so that the willing staff will submit his/her option in prescribed pro-forma within cutoff date.


The other terms and conditions which was notified in the notification dated-30.07.2021 is remain unchanged.
