Sub: Additional free time for cleaning activities of tank wagons in goods sheds in case of edible oil when there is change of product.

Ref: Corrigendum No.21 of Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 {PCCM/ECOR's Commercial Circular No.318(G)/2021 dated 15.09.2021}.

Please refer to Board's circular under reference regarding additional free time of four hours for cleaning activities (cleaning, mopping, coating and drying) of tank wagons in private siding(s) in case of edible oil when there is change of product. These guidelines are valid upto 31.03.2022.

The matter has been reviewed and it has been decided that above-mentioned guidelines will be applicable in case of goods sheds also.
