



In case any candidate is on leave/sick/deputation to other Railways or Units, the controlling officer(s) concerned should send necessary advice to the authority under whom he/she is working or medical authority as the case may be and acknowledgement obtained. The candidature of the candidates has been accepted provisionally. If any candidate is subsequently found ineligible at any stage of the selection, his/her candidature will be rejected without any further notice.

NB: As per extant rule, no supplementary examination is permissible in LDCE for the absentees.
