

Please refer to Para 5.0 of Rates Master Circular/ Provision of Weighbridge/2019/0 regarding permission for weightometer/pre-weighbin system of weighment in private sidings

The matter has been reviewed and it has been decided to revise the guidelines as given below:

- One-to-one correspondence between Weight-o-meter discharge and corresponding wagon must be available

All statutory compliance related to Pre-weighbin/Weightometer as well as its accuracy, reliability etc. must also be ensured at DRM's level.
