Sub: Haulage Charges newly manufactured BCACBM wagons, from Manufacturing Unit to the Base station.

Eastern Railway vide letter under reference (1) has raised the issue of Haulage Charges for newly built privately owned "BCACBM" wagons.

The matter has been examined in consultation with Rates and Finance Directorates of Railway Board and it has been decided that the provisions of Rates Circular No.29 of 2020 (ref-2) – regarding 'empty haulage charges for movement of newly manufactured privately owned wagons from the station near the manufacturing unit to the supply / delivery station shall be applicable on BCACBM wagons also.

All concerned to note and act accordingly.
