**Sub: Rationalization Scheme General Order No.01/2014 -Amendment No. 22-
Corrigendum No. 2.**

Refer Board's letter No. 2021/TT-III/27/1 dated 03.02.2022, the Amendment No. 22 of Rationalization Scheme General Order No.01/2014 [Circulated vide ECoR's Commercial Circular No.38(G)/2022 Dt.03.02.2022] may be read as under:
