


Sub: Delegation of power for waiver of Demurrage and Wharfage to DFCCIL
Ref: Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and its amendments

Please refer to DFCCIL's letter No.HQ-OPBD0BD(IDFP)/1/2022(14212) dt.22.03.2022 regarding delegation of power for waiver of Demurrage and Wharfage to officers of DFCCIL.

The power for waiver/write off of Demurrage and Wharfage are delegated to Zonal/Divisional level officers vide Chapter-III of Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and its subsequent amendments.

The matter has been examined and it has been decided that till Indian Railway is the sole operator on DFCCIL network, the extant guidelines will also be applicable to DFCCIL. The power for waiver/write off of Demurrage and Wharfage shall be exercised by the same level of DFCCIL officers, duly keeping in view the extant guidelines.

This is issued through consultative process with Traffic Transportation and Finance directorates of Railway Board.
