

Vide Board's letter dated 03.08.2018, all Zonal Railways were advised to launch a massive enrolment drive amongst the Railway employees by popularizing the schemes of Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) & Pradhan Mantri Jeevan Jyoti Bima Yojna (PMJJBY). Zonal Railways etc. were also advised to ensure that the benefits of these schemes reached the uninsured, the Railways/PUs etc. should also nominate a "Nodal Officer" in their Zone/Unit for carrying out large scale enrolment in co-ordination with Banks and Insurance Companies.

2. Vide Board's letters dated 08.03.2019 and 03.06.2019, the D.O. letter No. L-11011/04/2018-PW(Pt-I) dated 22.02.2019 from the Secretary, Ministry of Labour & Employment to publicise the Scheme of Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) and Pradhan Mantri Suraksha Beema Yojana (PMSBY) enacted under Unorganized Workers Social Security Act, 2008, was circulated to Zonal Railways/PUs etc. so as to facilitate enrolment of such workers including workers under contractors to provide social security to the workers of unorganized sector.

3. Board desires that all Zonal Railways/PUs may provide information on the number of Railway employees and other workers who have got enrolled under the respective schemes separately. The desired information may please be furnished to this office by 10.05.2022 positively.

**Sub:** Encouraging Railway employees to enroll themselves under PMSBY & PMJJB.

As the Railways are aware, the Hon'ble Prime Minister had launched Social Security Schemes pertaining to the Insurance Sector, namely the Pradhan Mantri Suraksha Bima Yojna (PMSBY) and the Pradhan Mantri Jeevan Jyoti Bima Yojna (PMJJB) on 9<sup>th</sup> May, 2015 to move towards creating a universal social security system, targeted especially at the poor and the under-privileged.

2. While PMJJB provides life insurance cover of Rs. 2 lakhs for a premium of Rs. 330 per member per annum (for any bank account holder in the age group of 18 to 50 years), PMSBY provides accidental insurance cover of Rs. 2 lakh for death or total disability for a premium of Rs. 12 per member per annum (for any bank account holder in the age group of 18 to 70 years). The schemes have been designed to provide convenient enrolment through auto debit of premium from subscriber's bank account and address low penetration of life and accident insurance in the country and enable targeting in favour of the poor, unorganized sector workers and the under privileged. They are offered/administered through Insurance Companies (both public sector and private sector) in tie-up with scheduled commercial banks, Regional Rural Banks, Cooperative Banks/Post offices concerned.

3. As these schemes are of national importance, Board desires that Zonal Railways/PUs should encourage and persuade all eligible Railway employees, who are still not covered under PMSBY and PMJJB to get themselves enrolled under the scheme to avail the benefits.

4. To achieve that Zonal Railways/PUs should launch a massive enrolment drive amongst the Railway employees by popularizing these beneficial schemes amongst them. For this purpose, the consent letter of the employees to join the schemes should be collected and it should be handed over to the respective banks in a function to be held for this purpose. The function should be held on Zonal levels on suitable dates. Forms can be downloaded from website [www.jansurksha.gov.in](http://www.jansurksha.gov.in).

5. In this connection, the Railways' attention is drawn to the CRB's D.O. letter referred to above. AM(Staff) has been nominated as the "Nodal Officer" for Railway employees. In order to ensure that the benefits of these schemes reach the uninsured, the Railways/PUs should also nominate a "Nodal Officer" in their zone/unit for carrying out large scale enrolments in co-ordination with Banks and Insurance Companies.
6. The Railways are requested to take appropriate necessary action in this regard under advice to Board's office at the earliest.

Hon'ble Finance Minister in his budget speech on 1<sup>st</sup> February, 2019 has announced a Pension Scheme for the workers in the unorganised sector such as street vendors, rickshaw pullers, construction workers, domestic workers, rag-pickers, agricultural workers, beedi workers, cobblers, handloom workers, washer-men, leather workers or engaged in 126 other similar occupations and whose monthly earnings are Rs. 15,000/- or less. The pension Scheme, named as "**Pradhan Mantri ShramYogi Maan-dhan (PM-SYM)**", targets about 42 crores unorganised workers in the country. The Scheme is being introduced under Section 3(1)(c) of *The Unorganised Workers' Social Security Act, 2008* which mandates the Central Government to formulate and notify suitable welfare schemes for unorganised workers on matters relating to old age protection.

2. PM-SYM is a voluntary contributory pension scheme. Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) pension scheme is already rolled out on 15<sup>th</sup> February, 2019 and now available throughout the country at all the CSCs. Hon'ble Prime Minister has kindly consented to formally launch the PM-SYM scheme in a central function on 4<sup>th</sup> March 2019 along with simultaneous launch in all State capitals/ major cities, all Central & State Government's Labour Offices and all the Common Service Centres (CSCs).

3. As you are aware, there are large numbers of unorganised sector workers who are working in your offices/Public Sector Undertakings/ vendors/contractors of PSUs under administrative jurisdiction of your Ministry. In order to extend benefit of old age security to the unorganised sector workers, coordinated efforts by all the Ministries are required to mobilize and enrol them under the scheme. The prospective beneficiaries may be informed about the features of the scheme, enrolment process and pre-requisite of having an Aadhaar Card and Savings/ Jan-Dhan Account passbook with IFSC code. After that they may be guided towards their nearest CSC, which can be located at the link **locator. CSC cloud in**. Ministry of labour and Employment has on-boarded Common Service Centre under the aegis of the Ministry of Electronics and IT (MeitY), as an enrolment agency for the scheme of PM-SYM.

4. You are requested to issue suitable instructions to Head of the PSU/autonomous bodies/subordinate Offices and other offices under your Ministry to mobilize the unorganised workers of such occupations as indicated above for enrolling them under the scheme.

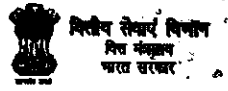
