
Notification for formation of Group-B Panel of 01-SC post of APO/AWO against 30% LDCE quota vacancy for the assessment period 2017-19 in Personnel Department was issued vide this office letter dated 15.10.2019 under reference. Eligibility list of 38 candidates with readiness notice for the pre-qualifying written test was issued vide letter dated 22.07.2020 under reference.

It has now been decided by the competent authority that the pre-qualifying written examination for APO/AWO against 30% LDCE quota will be held on **25.06.2022 (Saturday) at 11.00 Hrs at the Mixed Higher Secondary School, East Coast Railway, Khurda Road.**

All the eligible candidates should be informed accordingly and spared to report to the Presiding Officer of the examination at **10.00 Hrs on 25.06.2022 (Saturday)** for the written test with their proper Identification Memo. Candidates should note that Mobile phones, bags, books/note books, any electronic gadget, camera, Bluetooth etc. are not allowed inside the examination halls.


