


Please refer to FOIS mail dated 04.04.2022 wherein clarification has been sought regarding levy of Premium Charge when stock supplied and booked are different.

Extant guidelines regarding levy of Premium Charge are prescribed vide circulars under reference.

The matter has been examined and it is to advise that in situation when stock supplied and booked are different, Premium Charge shall be recalculated at the time of preparation of Railway Receipt, subject to the condition that the customer shows his/her willingness for loading in such a stock, as supplied by the railway, while placing demand for Premium Indent. CRIS/FOIS will make requisite provision in the system for the same.

These guidelines will be effective from 01.05.2022.
