NB (i) Shri Ramesh Chandra Mahalik (SC), has been empanelled against UR vacancy. The provisional panel of above Group 'C' staff for their appointment/promotion to the post of APO in Group-B Service has been approved by the General Manager/E.Co.Railway on 02.05.2022 and is in terms of PCPO/ECOR's Memorandum No. ECoR/Pers/Gaz/APO-70%/Sel/Panel/2017-19 dated 05.05.2022. Their promotion is subject to their not undergoing any punishment under the RS D&A Rules, 1968. They may exercise option for fixation of pay in Group'B'/Personnel service as APO within one month from the date of their promotion in terms of CPO's Estt.Serial No.231/81 and as per extent rules.

(ii) Shri Chhaku Ram Murmu, Ch.OS/GA/BBS in Group'C', having been empanelled provisionally for ad-hoc promotion to the post of APO in Group-B/Personnel vide PCPO/ECOR/BBS Memorandum No. ECoR/Pers/Gaz/APO-70%/Sel/Panel/2017-19 dated 05.05.2022 for a period for six months under the principle of 'best among failed SC/ST candidates'. Inclusion of his name in the panel will depend upon his performances during the six months period after the date of his ad-hoc promotion in terms of Railway Board's letter No.88-E(SCT)/23/1 dated 28.06.1995. The ad-hoc promotion as and when given shall not confer any right upon him to claim automatic empanelment to APO/Personnel. He should be given all facilities to improve his knowledge and come upto the requisite standard, if necessary, by organizing special coaching classes during the six months period of his ad-hoc promotion. On completion of his six months' ad-hoc

promotion, his case will be put up to the General Manager on the basis of special working report of the candidate for a review and continuance of the said candidate in the higher grade will depend upon this review. The staff concerned, if failed to come up to the requisite standard after taking all steps as above, will not be included in the panel and the vacancy will be treated as shortfall. On being finally empanelled, his position in the panel will be assigned at the appropriate place.
