Vide Board's letter of even number dated 30.08.2022 (RBE No. 105/2022) detailed instructions have been issued regarding crew review of running staff and modalities for periodic balancing of staff excess/ shortage. Para "n" of the aforesaid instructions is amended partially & will be read as under:

"If need arises, options of staff in these categories may be invited for absorption in other categories/ departments provided these are in the same pay level and they undergo suitable training. This deployment may be made against DR quota subject to the staff meeting prescribed eligibility criteria. Seniority and Pay fixation of such staff on their absorption in alternative categories should be as per extant rules for surplus staff."
