**Terms and conditions of re-engagement of retired employees.**

1. The Scheme is valid up to One Year from the date of re-engagement and extension will be subject to administrative requirement.
2. The retired Railway employees of above categories can only apply against their post and department.
3. The employees retired voluntarily under the SRSS/LARSGESS Scheme are not eligible to apply for re-engagement.
4. The service of re-engaged employees will be terminated on either of the following conditions:-
  - i) On attaining the age of 65 years, or, on completion of validity of the scheme i.e. One year from the date of re-engagement, whichever is earlier.

**Or,**
  - ii) Till the vacancies are filled up by the candidates selected through RRB/RRC/Departmental tests.


**Or,**
  - iii) At any time, administration has the right to terminate the service of re-engaged employees even before One year from the date of re-engagement or in case their work/conduct is not found satisfactory.

5. The re-engagement shall be subject to the suitability of retired employee being adjudged by the nominated committee and being found medically fit for the post.
6. The re-engagement can be terminated by giving 7 days notice without any explanation or any reason.
7. Monthly remuneration of a retired employee being re-engaged will be determined by reducing Pension from his/her last pay drawn(i.e. Basic Pay + DA).
8. The duty hours of the re-engaged employee would be as per the requirement of work by the administration. The re-engaged employee will not be eligible for any kind of leave. Absence from duty if any, appropriate deduction will be made from the monthly remuneration.
9. Self attested copies of the following documents should mandatorily be attached with the application:
  - i) Service Certificate.
  - ii) Pension Payment Order.
  - iii) Aadhar Card.
10. The last for submission of the application is 07.01.2023.
11. The retired railway employees fulfilling the criteria mentioned above, willing for re-engagement for their belonging post, should send their Scanned applications to the E-mail Account ; **dpo.sbp06@gmail.com** on or before is 07.01.2023

or

Retired staff can submit their applications directly in the central receipt and dispatch of the Sr. DPO's Office on or before is 07.01.2023.

12. Application should be made in prescribed format (Annexue-A) only. Application sending twice on E-mail are not taking into consideration. Application received after due closing date/ time , for any reason whatsoever, will not be considered.
