

The required documents viz. Confidential Reports/APARs for the years 2015-16, 2016-17, 2017-18 2018-19 & 2019-20, Service Book, D&A clearance and original medical fitness certificates of prescribed standard for the post of Law Officer (Group-B) of the above candidate, for the viva-voce test, should be sent to Dy.CPO(Gaz) **latest by 20.12.2022** positively.

In terms of Railway Board's letter No. E(GP)80/2/8 dated 31.10.91 only those candidates who qualify in the medical examination of prescribed standard should be advised to appear in the viva-voce test. Accordingly, the respective controlling officer/Personnel Officer should direct the above candidate for medical fitness of prescribed standard for the post of Law Officer (Group-B) before the viva-voce test.


