**Sub Traffic to the Greenfield Private freight Terminal (PFT) of Container Corporation of India Ltd.**

Greenfield Private Freight Terminal (PFT) of Container Corporation of India Ltd. (Alpha Code: CCJS & Numerical Code:12328734), of WAT Division was notified open for Goods traffic on through distance basis as a full rake handling point vide commercial circulars under reference with the following permitted commodities:


- a) Inward: All except POL.
- b) Outward: All except Coal and Coke under priority "C" and POL.

Now with the approval of competent authority, Outward loading of Coal and Coke under priority "D" as outward commodities have been permitted for the PFT. The revised list of permissible commodities for the PFT with this inclusion is as under.

- i) Inward : All except POL
- ii) Outward: All including Coal and Coke under priority "D" except POL.

All extant rules for booking of Coal under priority "D" to be followed.  
Booking of coal and coke under priority "C" is not permitted.  
All other terms and conditions of the circulars under reference shall remain unchanged.


