- 6) The list of eligible and ineligible candidates vide Annexure-I and Annexure-II, respectively may please be widely circulated and served to the eligible candidates with proper acknowledgement.
- 7) Representations if any against the list of eligible and ineligible candidates may be preferred to the Dy.CPO(Gaz)/BBS on or before 16.01.2023, so that the same will be put up to the competent authority for finalization. Representations received beyond 16.01.2023 by PCPO's Office will not be entertained.
