Sub: Change in name of the Private siding of NMDC Limited to Private siding of M/s NMDC Steel Limited at Amagura (NMAG).

Ref: This office's Commercial Circular Nos. 218(G)/2018 Dt.16.11.2018, No.114(G)/2019 Dt.17.06.2019, No. 233(G)/2019 Dt.19.11.2019, No. 70(G)/2020 Dt.27.03.2020, No.244(G)/2020 Dt.28.09.2020, No.110(G)/2021 Dt.19.03.2021 and No.103(G)/2022 Dt.30.03.2022.

- 1) Vide Commercial Circular No.103(G)/2022 dtd.30.03.2022, the notification of Private siding of M/s National Mineral Development Corporation Limited (NMDC Limited) served by Amagura station over Waltair Division with Alpha code-NMAG & Numerical code-12322531 was valid upto 31.03.2023.
- 2) Consequent upon the Scheme of Arrangement between NMDC Limited (Demerged Company) and NMDC Steel Limited (Resulting company) and their respective shareholders and Creditors, the name of Private siding of M/s NMDC Limited served by Amagura is hereby changed to Private Siding of M/s **NMDC Steel Limited** served by Amagura.
- 3) To facilitate uninterrupted booking and accountal of traffic the **Alpha Code - NMAG & Numerical Code - 12322531** of the siding shall remain unaltered.
- 4) All other terms and conditions of the commercial Circulars under reference shall remain unchanged.
- 5) This notification will remain valid upto **31.03.2023**. During this period, the siding owner has to complete all the formalities for change of name in Land Licensing Agreement, Siding Agreement Plan, Siding Agreement and in all relevant railway documents.
