1. The Non Functional Up-gradation of the above candidates is provisional and subject to judgments of Hon'ble Supreme Court or the High Court as the case may be in respect of Writ Petitions and appeals pending in the said Courts.
 2. Benefits of pay fixation as per Rule 13 of CCS (Revised Pay) Rules-2016 shall be available at the time of NFU. Option for pay fixation may be exercised within one month of issue of order.
 3. After the grant of NFU in Level-9 and pay fixation under Rule-13 of CCS (RP) Rules 2016, there will be no further pay fixation on promotion to Level-9.
 4. NFU will be reckoned for financial up gradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial up gradation under MACPS, if any, is to be reckoned from the date of grant of NFU.
 5. The designation, duties & responsibilities, seniority and classification in Group 'C' of employees will remain unchanged after grant of NFU to Level-9.
 6. If any further modalities or terms & conditions for implementing these orders are issued by Rly. Board on a later date, the same will prevail.
