Relevant extract of Railway Board's letter No. TCR/1078/2022/MGR Policy/3386488 (Rates Circular No.08 of 2023) dated 28.04.2023 is reproduced for below for information and necessary action:

Sub: Operation of Merry-Go-Round (MGR) System by Railways.

Ref: Rates Circular No. 07 of 2016 Dt.23.03.2016, Rates Circular No.17 of 2016 Dt.20.05.2016, Corrigendum No. 01 to Rates Circular No. 17 of 2016 Dt.22.03.2018, Rates Circular No. 9 of 2018 Dt.26.04.2018, Rates Circular No. 18 of 2018 Dt.26.10.2018, Rates Circular No. 17 of 2021 Dt.28.04.2021 and Rates Circular No. 12 of 2022 Dt.28.04.2022 {PCCM/ECOR's Commercial Circular Nos. 28(G)/2016 Dt.28.03.2016, No. 67(G)/2016 Dt.23.05.2016, No. 58(G)/2018 Dt.26.03.2018, No.86(G)/2018 Dt.27.04.2018, No. 205(G)/2018 dt.29.01.2018, No. 157(G)/2021 Dt.29.04.2021 and No. 154(G)/2022 Dt.02.05.2022 respectively}.

1. In terms of above referred Rates Circulars, the Operation of Merry-Go-Round (MGR) Systems by Railways is up to 30.04.2023.
2. The matter has been reviewed and the Competent Authority has decided to extend the validity of the system beyond 30.04.2023 for a further period of one year i.e., up to 30.04.2024.
3. It has also been decided that for the operation of the MGR system beyond 30.04.2023, the current rates shall be enhanced by 5% (five percent).
4. The Zonal Railways where the system is operative should monitor the same with a view to increase traffic.
5. All other terms and conditions stipulated in above referred Rates Circulars shall remain unchanged.
6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
