Applications are invited for engagement of "Contract Medical Practitioner" on contract basis at Divisional Railway Hospital, Sambalpur. Willing MBBS Doctors, who fulfil the Qualification/eligibility criteria specified below, may apply for the above engagement on mail id of cms_sbp@sbp.railnet.gov.in. The engagement will be offered purely on contract basis for a period of one year or till the scheme become available or posting of a regular incumbent whichever is earlier, which can be renewed as a fresh contract on year to year basis. The last date for submission of application on above mail id is 05.07.2023.

Eligible and willing candidates may send the scanned copy of their application in the prescribed format along with scanned copies of their Certificates/Work Experience Certificates (if any)/Testimonials on mail id cms_sbp@sbp.railnet.gov.in. After scrutiny of the application, interview through video conferencing/Video calling would be taken of eligible candidates for which they would be intimated through their e-mail & whattsapp number. Selected candidate will be intimated through the whattsapp number/ Email Id of the candidate. While reporting for duty, the candidate will be required to bring all the original Certificates/Testimonials for verification and two passport size photographs. After due verification of the Certificates/Testimonials, the final engagement order will be issued.

EDUCATIONAL QUALIFICATION/ELIGIBILITY:

The candidate should be a minimum MBBS pass degree from an institute recognized by the Indian Medical Council and with registration in Indian Medical Council, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year of compulsory, rotatory Internship. No other certificates will be accepted.

- AGE (i) Not exceeding 53 years of age as on the date of engagement, However, age relaxation is admissible for SC/ST/OBC category candidates as per rules.
 - (ii) For retired Railway Doctor, retired Government Medical Doctors of State Governments and Central Government, age up to 63 years as on the date of engagement.

REMUNERATION:

- a. The rate of remuneration is ₹ 75,000/-(including HRA & Transport Allowance) for Full Time General Duty Medical Officer (GDMO). For retired Railway Doctors, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration is Rs.75000/-, subject to the condition that the pension plus contractual remuneration of the Retire doctors should not exceed than the last pay drawn at the time of retirement .No dearness and any other allowance which are admissible to regular railway servants shall be admissible.
- b. Normally Sunday and national holidays will be off and in addition, authorized absence without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP till such time subject to fulfillment of conditions. Daily rate of proportionate reduction from the remuneration in the event of excess absence will be applicable.
- c. In case Railway accommodation is provided to the CMP an amount of equivalent to HRA and licence fee of the accommodation so provided shall be deducted from monthly fees admissible.

OTHER TERMS AND CONDITIONS:

- I. Selected candidates will be subjected to medical examination and only medically fit candidates will be engaged as CMP.
- II. The Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
- III. During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any otherground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railways administration if the CMP is found to be mentally or physically incapacitated
- IV. Engagement as CMP will not confer any right for automatic regularization or absorption in railways.
- V. The CMP may avail of free medical treatment for self only except operations categorized as 'special' in para 622(8) of IRMM 2000 and treatment normally available at super specialty centre from his/her respective zonal railway hospitals during the period of contract.
- VI. The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- VII. The administration of the ECoR/Sambalpur division reserves absolute right to cancel this without assigning any reason(s).
- VIII. One set 1st class complimentary Railway pass for self and family during each contractual year shall be issued after 03 months continuous engagement.
- IX. No Railway privilege passes/PTOs shall be admissible to Retired Railway Doctors engaged as CMP in his/her capacity of CMP. However, 'Duty passes', as per eligibility would be provided for outstation duties to the CMPs.
