The required documents viz. Confidential Reports/APARs for the years 2016-17, 2017-18, 2018-19, 2019-20 & 2020-21, Service Book, D&A clearance and original medical fitness certificates of prescribed standard for the post of Law Officer (Group-B) of the above candidates, for the viva-voce test, should be sent to SPO(Gaz) latest by 23.06.2023 positively.

In terms of Railway Board's letter No. E(GP)80/2/8 dated 31.10.91 only those candidates who qualify in the medical examination of prescribed standard should be advised to appear in the viva-voce test. Accordingly, the respective controlling officer/Personnel Officer should direct the above candidates for medical fitness of prescribed standard for the post of AHO (Group-B) before the viva-voce test.

The candidature of the above candidates appearing in the viva-voce test has been accepted provisionally. If they are subsequently found ineligible at any stage of the selection, their names will be deleted without further notice.

This notice should be got noted by the above named candidates. In case, they are on leave/deputation/serving in other units or in sick list, necessary advice should be sent to their address or the Authority with whom they are working or through the Medical Authority as the case may be, without fail and the acknowledgement obtained from the Authority/employee may be kept in record and sent to this office when asked for.
