Sub: Notification for filling up the post of Stenographer Grade-I in Level-06 at East Coast Railway against 100% Departmental Promotion Quota.

If the above named staff are on leave or sick they may be intimated in their leave or sick address regarding the above notification and alertness for stenography test.


