

**INTRODUCTION :-**

- (a). At the outset, the convener and Sr.DPO welcomed the Chairman/PNM & ADRM(OP), GS/ECoRSU, DC/ECoRSU, Branch Officers and other representatives of ECoRSU present in the 1<sup>st</sup> Divisional PNM meeting held on 15.09.2022 & 16.09.2022 respectively.
- (b). The convener, informed that after a long time, the Divisional administration is holding this first Divl.
