
It is to mention that the candidature of the applicants are purely provisional and may be rejected at any stage if any discrepancy is found later on regarding their eligibility to the post.

The syllabus for the written test was circulated earlier vide this office letter No.ECoR/Pers/NG(Admn)/02/Selection/Ch.S&WI/LDCE, dated: 14.08.2023. Pre-selection coaching is not required as no reserved community candidate has applied for the SC post as per extant rules.


