**Commercial Circular No.301(G)/2023**

**Sub: Classification of "Ferro Chrome".**

1. The subject commodity was classified at Class - 165 w.e.f. 11.10.2021 till 10.10.2022 in terms of Rates Circular No.30 of 2021 dated 11.10.2021. The same has been extended upto 31.10.2023 in terms of its Corrigendum No.01 dated 11.10.2022 {circulated vide CCM/ECoR's Commercial Circular No.332(G) / 2022 dated 11.10.2022}.
2. The matter has been reviewed and the Competent Authority has decided to revise the classification of "Ferro Chrome" at Class - 180 under Main Head "Alloys and Metals" in Group No.2, at page No.8 of IRCA Goods Traffic No.49, Part.I (Vol.II) for a period of one year beyond 31.10.2023 upto 31.10.2024.
3. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways
