











**GOOD WORK DONE BY RPF/ECOR FOR THE PERIOD FROM 01.10.2023 TO 31.10.2023.**

1. On 02.10.2023, CIB Team KUR apprehended one tout viz. Basudev Acharrya, age 34 yrs from Digital seva Kendra Dubri Chhak Kalinga near Jajpur with seizure of 03 nos. future Rly reservation tickets ( value Rs-614.15) & 03 past tickets( value Rs-1678.80) total valued Rs 2292.95/- . The arrested person with seized property were handed over to PC/RPF/JJKR where RPF/Post/JJKR registered a case vide No.420/2023 dtd. 02.10.2023 U/S 143 Railway Act against him. 
2. On 03.10.2023, Excise/Titlagarh and officer & staff of RPF Post Titlagarh apprehended 01 Ganja peddler viz. 23. On 17.10.2023 officers & staff of RPF/Post/Khurda Road along with CIB Unit/Khurda Road apprehended one Ganja peddler viz. Chittaranjan Patro, aged 31 years with the seizure of 5.930 kg Ganja valued Rs.59,300/- from PF No.04 of Khurda Road Railway station. The apprehended person along with seized Ganja was handed over to GRPS/Khurda Road, who registered a case vide Crime No.106/2023 Dtd.18.10.2023 U/S-20(b) (ii) B of NDPS Act-1985.
