Sub: Commercial notification of 16th rake of BOXNHL25T wagons (61 wagons including 03 spare wagons) and one B/Van of M/s Rungta Sons Pvt. Ltd. under General Purpose Wagon Investment Scheme (GPWIS).

- Railway Board vide letter No. 2021/TC (FM)/04/07 dtd.15.03.2022 have granted approval to M/s Rungta Sons Pvt. Ltd. to procure and operate 11 BOXNHL rakes (including 4% spare wagons) and 11 Brake Vans. In this regard, the customer has executed GPWIS agreement No. PCCM/GPWIS/RSPL/2022/2 on 07.04.2022 with this office.
- 2) Further, Railway Board vide letters No. 2021/TC(FM)/4/7 dtd.19.04.2022 have approved for addition of Authorized Users for these rakes.
- 3) Vide letter No. 2021/TC(FM)/4/7 dtd.02.06.2023, the Board have approved for modification in circuits for these 11 rakes approved vide letter dated 15.03.2022.
- 4) Vide letter No. 2021/TC(FM)/4/7-Part(1) dtd 01.09 2023, Railway Board have granted approval for extension of time for induction of 11 rakes for 18 months over and above the 18 months period available for induction of the rakes, after signing the agreement. The Board have further circulated the new modified circuits for these rakes.
- 5) M/s Rungta Sons Pvt. Ltd has handed over their 4th BOXNHL25T rake under Railway Board's above mentioned approval letters, consisting of 61 BOXNHL25T wagons (one rake including 03 spare wagons) and one Brake Van which will be their 16th rake in total. The list of the wagons is enclosed as Annexure-1.

- 8) The subject rake will not be merged in IR's pool of wagons and will be distinctly indicated through a colour scheme. The rakes so inducted shall run on aforementioned circuits only.
- 9) Maintenance of these wagons will be undertaken by IR on payment as per GPWIS agreement No. PCCM/GPWIS/RSPL/2022/2 dtd.07.04.2022 executed with M/s Rungta Sons Pvt. Ltd. The subject rake will be maintained at maintenance depot situated at Paradip (PRDP) of East Coast Railway.
- 10) For each loaded rake of M/s Rungta Sons Pvt. Ltd. (consisting of wagons mentioned in Annexure-1), RRs are to be marked as "M/s Rungta Sons Pvt. Ltd.'s rake under GPWIS".
- 11) Under GPWIS, M/s Rungta Sons Pvt. Ltd. is eligible to get a freight rebate of 10% on the Base freight rate prevailing at the time of booking. This freight rebate will be granted whenever the rakes move in loaded condition in the approved circuit. Modalities for granting rebate under GPWIS is as below:
 - a) When the investor i.e. M/s Rungta Sons Pvt. Ltd. pays the freight either as Consignor or Consignee the rebate shall be granted on the RR itself.
 - b) When the freight is paid by authorized user as Consignor or Consignee, then the rebate amount will be credited to "Deposit Miscellaneous" account specially created under a separate head for GPWIS repayment.
 - c) Similarly, when the rake is loaded in the empty direction by Railway as per Para 5.13.1 of GPWIS agreement, the rebate amount will be credited to "Deposit Miscellaneous" account.
- 12) The amount of freight so accumulated in "Deposit Miscellaneous" will be reimbursed to party on quarterly basis through reconciliation.
- 13) CGS/Station In charge of concerned loading/unloading point shall maintain a separate record of each movement of GPWIS rakes of M/s Rungta Sons Pvt. Ltd. As and when required, a joint team consisting of CGS/Station In charge, CMI and TIA will calculate freight rebate applicable under the scheme for each RR and submit their report to PCCM/ECoR with details of the movement.
- 14) The subject BOXNHL25T rake will be governed by GPWIS Agreement No. PCCM/GPWIS/RSPL/2022/2 dtd.07.04.2022 and GPWIS policy issued by Railway Board vide circular No. Freight Marketing Master Circular/GPWIS/2018/0 dtd.26.04.2018 {PCCM/ECoR's Commercial Circular No.88(G)/2018 dtd.01.05.2018} and corrigendum/ addendum thereto issued by Railway Board from time to time.
