Sub: Conversion of 120 BOXNHL wagons inducted by M/s T M International Logistics Limited under GPWIS into BOXNHL 25T wagons.

Ref: PCCM/ECOR's Commercial Circular No. 212(G)/2023 dated 24.07.2023 & No. 318(G)/2023 dtd. 02.11.2023.

- 1) Vide PCCM/ECOR's commercial circulars under reference, the 20th (Agreement ID in FOIS - **TMITECO240720231247**) & 22nd (Agreement ID in FOIS - **TMITECO021120231149**) BOXNHL rakes of M/s T M International Logistics Limited were respectively notified under GPWIS.
- 2) Railway Board vide letter No.2018/TC(FM)/4/06 dtd.12.03.2021 have issued instructions that the BOXNHL wagons procured under GPWIS would be converted into BOXNHL 25T wagons.
- 3) Accordingly, BOXNHL wagons of the above mentioned two rakes (20th & 22nd) have been converted into BOXNHL25T wagons at their maintenance depot at Paradip (PRDP) of East Coast Railway.
- 4) GPWIS module of TMS/FOIS has been modified accordingly with respect to the wagon type, PCC etc. of these wagons in individual Agreement ID.
- 5) The list of the modified wagons is enclosed as Annexure-1.

All other terms and conditions of the commercial circulars under reference will remain unchanged.
