NOTIFICATION

- विषय /Sub: Centralized selection for promotion to the post of Sub-Inspector (Executive) for all Zonal Railways/RPSF under rule 72 of RPF Rules, 1987 (Amendment 2021).

In reference to the above, it is proposed to hold a competitive test to fill up 05 vacancies of Sub-Inspector in Level-6 of Pay Matrix (7th PC) according to the post based roster points under Rule 72 of RPF Rules, 1987 (as Amended in 2021) with the following community wise break up:

Community	UR	SC	ST	Total
Vacancies	05	0	0	05

The selection will be held in accordance with RPF Establishment Manual, RPF Rules, 1987 (Amended in 2021), read with schedule IV of RPF Rules, 1987 (Amended in 2021) and Railway Board's guidelines, issued vide letter No.2021/Sec(E)/PM-3/13 dated 13.01.2022 and other extant provisions.

In this regard, it is brought to the notice of all concerned that the instructions contained in Railway Board's letter No. 2021/Sec (E)/PM-3/6 dated 01.06.2022, letter No. 2018-E(SCT)1/25/9 dated 02.05.2022, letter No. 2018-E (SCT)/1/25/9 dated 22.06.2022 and letter No. 2021/Sec (E)/PM-3/6 dated 11.08.2022 shall be strictly followed.

Accordingly, as per provisions-

- The date of eligibility for Constables, Head Constables and Assistant Sub- Inspectors who have put in 12 years of total service including initial training period in executive cadre of the force has to be counted as on 21.08.2023.
- The candidates should not be more than 45 years of age on the date of Notification i.e. on 21.08.2023.
- Three chances are to be given for promotion under this rule.
- As advised by Railway Board vide letter No. 2021/Sec (E)/PM-3/13 dated 21.07.2023 that a **proviso should be inserted in the notification that the staff, who were eligible as per the earlier notification dated 01.06.2022 issued in compliance to PCSC/CR (Nodal PCSC for SIPF Selection U/R 72) letter No. E-20/PCSC/Selection/SIPF U/R-72/2022 dated 06.05.2022, will be allowed to appear in the selection as one time relaxation.**

The eligible staff concerned may be intimated that the written examination shall be held through CBT (Computer Based Test) and they should go through and make themselves properly aware about the provisions relating to the selection process as per RPF Establishment Manual 2019, RPF Rules, 1987 as Amended in 2021, Railway Board's guidelines issued vide letter No.2021/Sec(E)/PM-3/13 dated 13.01.2022 and other extant provisions.

All the concerned divisions and all unit in-charges of HQ/BBS including SIB/CIB of the divisions are requested to ensure that wide publicity is given about this selection amongst all the eligible staff on roll (including staff either under sick/absent/overstay/suspension etc. or on deputation to other organizations/ departments) on proper acknowledgement to avoid any complications.

The mode of application will be offline. The eligible staff may be asked to submit their written application in duplicate in the format vide **Annexure "A"** to their immediate Post/Unit in-charges to appear in the selection test **within 15 days** from the date of Notification. As such **last date of submission of application** to their Controlling Officer (Immediate Post/Unit in-charges) by eligible candidate will be **05.09.2023**. To avoid entertaining late application at Post/Unit level, making diary entry of candidates submitting application may be ensured please.

After last date of submission of application, the Post/Unit In-Charges shall convey the number of candidates who have submitted applications for appearing in the Selection Test and forward the original applications of the candidates in duplicate to Sr.DSC/DSC office on next day i.e. **06.09.2023** for necessary scrutiny of applications.

The concerned Divisional Authority/Unit Head (here in after called as "**Controlling Authority**") on receipt of the applications shall make proper scrutiny of the applications with the Service Record of staff to determine their eligibility for the selection process. This scrutiny process shall be completed within three days time i.e. by **09.09.2023**.

On completion of scrutiny process, the Controlling Authority shall forward all applications of eligible staff in **proforma mentioned below to Zonal PCSC** along with a certificate to the effect that **"each eligible staff has been advised on proper acknowledgement about the proposed selection and no other applications have either been received or pending at his end "**.

They will also communicate number of eligible candidates in their division to PCSC at the end of scrutiny on **10.09.2023**. Zonal PCSC in turn shall convey the consolidated number of eligible candidates from their zone to DPC-Chairman on or before **13.09.2023** through government mail. Id, so that venue of examination can be decided depending upon the number of eligible staff.

The concerned PCSCs, on receipt of data from Controlling Authorities, shall also submit a detailed statement in following proforma in Excel format through mail to Chairman DPC at his government mail Id, rainish.9in@gov.in by **13.09.2023**. Further, hard copy of completed proforma in sealed cover along with one copy of application submitted by the eligible staff concerned to be sent to DPC Chairman by 14.09.2023. One copy of application submitted by staff shall be retained in respective PCSC office for records purpose.

Sr.DSC/DSCs shall ensure that Service Records are updated and shall ensure preparation, verification and certification of the details of service and APAR grading for the period from 2018-19 to 2022-23 in the enclosed broadsheet mentioned in "Annexure-B and send the same to the PCSC office duly signed by a Gazetted officer for onward submission to the Chairman DPC duly signed by a Gazetted officer authorized by PCSC concerned.

If any of the APARs is not available in case of any candidate, non-initiation certificate (NIC) along with previously available APAR grading prior to these 5 years should be submitted. The updated Service Records as well as APARs of eligible candidates for the period from 2018-19 to 2022-23 may also be kept ready in the office of respective Controlling Authority to be cross examined by DPC at short notice as and when intimated to the zone.

In terms of RPF Establishment Manual all the eligible candidates have to bring their official Photo Identity Card in addition to the Command Certificate/Movement Order bearing signature of the candidate duly attested by Post/Unit in-charges at CBT Exam Centre to prevent impersonation.

It is therefore advised to ensure that necessary photo ID cards in favour of eligible willing candidates are issued, if not in possession.

The eligible staff concerned who applies to appear in the Selection Test may also be advised to be in readiness to appear in the Selection Test at short notice. If any staff is on leave, sick etc., they may be advised through messenger and acknowledgement be kept in office for record purpose. All efforts may be made to ensure that all the eligible staff are able to submit their applications by the deadline.

Further it is to inform that the above selection is subject to the outcome of the ongoing court cases pertaining to selection.
