विषय/Sub: Formation of Gr.B/Civil Engg. Panel of AEN against 70% selection through Special Drive for vacancy cycle 2023-24 in Civil Engg. Department/ECoR.

1. Railway Board, vide letter No. E(GP)2022/2/4 dated 14.12.2023, has decided that a special Group 'B' selection drive shall be carried out to fill up the Gazetted vacancies by holding another round of 70% selection and 30% LDCE through Centralized Computer based objective type examination (CBT) by NAIR.
2. Accordingly, it has been decided to hold Centralized Computer based objective type examination (CBT) for formation of Group-B Civil Engg. Panel of 08 (03-UR, 02-SC & 03-ST) posts of AEN against 70% selection vacancy in Civil Engg. Department of East Coast Railway. The above vacancies include two posts for PwBDs in the categories HH (Deaf & hard of hearing) and VH (blindness & low vision) as per Railway Board's Letter No. E(GP)2022/2/20 dated 18.08.2022.
3. The Centralized Computer based objective type examination for 70% selection shall be held on **25.02.2024 (Sunday) at Bhubaneswar centre only by DG/NAIR.** Further instructions on conduct of CBT will be intimated in due course. **There shall be no supplementary examination for this special 70% selection.**
4. **Conditions of Eligibility:**
 - I. As per Recruitment Rules for the Group-'B' post of Assistant Executive Engineer published by Railway Board vide Notification No. 2015/E(G)RR/15/2(Civil) dated 11.11.2020, Non-Ministerial Group-C staff of Civil Engineering Department holding the post in Level-6 and above in the pay matrix with three years of regular service in level-6 and above in the pay matrix, are eligible to appear for the selection.
 - II. Where juniors who have completed their qualifying or eligibility service and are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.
 - III. The service will be reckoned as on **01.01.2023.**

5. A provisional list of 38 Nos. of eligible candidates (24 candidates in order of seniority as per Provisional Integrated Seniority list published vide letter No. ECoR/Pers/04/Engg/Integrated Seniority List/AEN-70% dated 13.11.2022 as per extant rule, 13 against twice failed and 01 SC candidate against extended field of zone of consideration) of Civil Engg. Department of ECoR who have completed minimum three years of non-fortuitous service in Pay Level-7 as on 01.01.2023 (Cut off date) and are coming in the zone of consideration is enclosed at Annexure-A. Also an additional list of 38 Nos. of candidates, next in order of seniority of Civil Engg. Department of ECoR who have fulfilled the eligibility criteria are placed in the Stand-by List at Annexure-B. Against any unwilling candidate of Annexure-A, the willing candidate of Annexure-B may be considered for the CBT to the extent of making good the zone of consideration.
6. The candidature of the candidates is accepted provisionally. In case, any candidate is subsequently found ineligible for the above selection at any stage, his/her candidature will be rejected without any further notice.
7. The eligible candidates enlisted at Annexure-A & B should submit their options (willingness/unwillingness) **on or before 10.01.2024** in the attached format (Annexure-C) to the concerned Personnel Officers duly forwarded by their respective controlling officers and the same should be forwarded to the Dy.CPO (Gaz) **on or before 16.01.2024** positively in a consolidated statement along with the individual options.
8. It is the employee's responsibility to advise his/her willingness/unwillingness to take the selection, and failure to respond or to provide the intimation within the period allowed will be treated as unwillingness on his/her part to take the selection. If willingness/unwillingness is not received within the above mentioned stipulated date, it will be deemed that the candidate has availed of the opportunity of appearing in the selection & it will be treated as his/her unwillingness to take the selection.
9. In case any candidate is on leave or on deputation to other Railways/Units/office or on sick list, the Controlling officer concerned and the offices where he/she last worked should send necessary advice to the authority under whom he/she is working or the Medical Authority as the case may be and an acknowledgement obtained. Options of the staff concerned should not be sent to this office directly. Personnel officers should ensure that options received by their offices after **10.01.2024** should not be forwarded to this office under any circumstances. All the particulars filled by the applicants at Annexure- C (Option form) should be verified by Personnel Officers before forwarding to HQrs office. Their IPAS numbers, HRMS ID, Mobile numbers and e-mail ID should be verified since the examination will be conducted through CBT and all future correspondences with the applicants will be done with their IPAS, Mobile number and e-mail ID. The nature of physical disability of the candidates applied against PwBD category must have such entry in their respective Service Records and it should be verified by the respective Personnel Branch. Names of those staff who have not fulfilled the eligibility criteria as mentioned above need not be forwarded.
10. Pre-Promotional Training (PPT) for a period of 60 hours or 15 working days/On line/Off line to the enlisted and willing SC/ST candidates should be arranged by the Executive side in terms of Railway Board's letter No. E(GP)2022/2/4 dtd. 18.10.2022. **The same should be completed by 16.02.2024 positively and compliance report to be sent to this office immediately.** As it is mandatory, refusal, if any, should be obtained in writing.
11. **Objective and Scheme of Examination:** The examination aims at a comprehensive assessment of knowledge of the candidates related to their professional ability, Official language policy, Establishment and Financial Rules. ***The formation of the panel will be on the basis of 'Seniority-cum-Suitability'.*** Selection of candidates for empanelment is based

on a (i) CBT Examination on a single day (ii) Viva-voce (with prior Medical Fitness test) and Assessment of Record of Service by the Selection Committee.

12. **CBT Examination:** In order to bring objectivity to the Selection process, it has been decided by Railway Board vide letter No. E(GP)2022/2/4 dtd. 07.10.2022 read with RBE No. 53/2019 that the CBT examination shall comprise of one Paper which shall have 100% Objective type Multiple Choice Questions only. The paper will be of 100 marks with distribution as given below:-

- Professional Subject including optional questions
of 10 marks on Official language policy & Rules : 70 marks
- Establishment and Financial Rules : 30 marks
- Qualifying marks : 60
- All objective type questions carry equal marks.
- There shall be negative marking for incorrect answers. One-third of the marks allotted for each question will be deducted for every wrong answer.
- The duration of the examination for 70% selection through CBT shall be of **02 hours**.



The Controlling Officers/Sr.DPO/DPO/WPO/SPO of concerned Unit/Division should ensure that the ACRs/APARs of the candidates for the last five years i.e. 2017-18 to 2021-22 completed in all respects, SRs & Personal files are kept ready with them and they should send the same to Dy. CPO(Gaz) when called for.
16. In terms of Railway Board's letter No. E(GP)80/2/8 dtd. 31.10.91 only those candidates who qualify in the medical examination of prescribed standard are eligible to appear in the viva-voce test.
