**Sub:** Restriction of Parcel traffic over Delhi area in connection with Republic Day-2024.

Extract of the Dy.CCM(FM)/Northern Railway's letter No. 36-RD/982/Restriction/ Parcel/Pt-III dated 05.01.2024 is reproduced below for information & necessary action:-

“Keeping in view the security arrangements during Republic Day celebrations, restriction is hereby imposed on all types of Parcels handling activities (including handling leased SLRs, VPs & demand VPs) in Delhi area (i.e. NDLS, DLI, HNZM, ANVT, DEE & ANDI) from 23.01.2024 to 26.01.2024. Parcel godowns and platforms shall remain free of parcel packages / packings. In the wake of special arrangements this year, restriction is imposed on both inward & outward parcel traffic including leased SLRs & VPs (including demand VPs) at all the aforesaid stations.

The personal luggage may be allowed in the passenger coach only and booking of registered newspapers and magazines shall be permitted after observing all commercial formalities.

This restriction is applicable on all types of parcels transactions (including handling leased SLRs, VPs & demand VPs) of the trains originating from Delhi area stations (i.e. NDLS, DLI, HNZM, ANVT, DEE & ANDI) and also applicable for passing trains originating from other divisions/zones, having stoppages in Delhi area for loading / unloading”.

All concerned to note and act accordingly.
