

Sub: Rates for Automobile Traffic carried in single stack on BCACM wagons.
Ref: Board's Rates Circular no.32 of 2021 dated 30.11.2021 and its corrigenda.

1. The freight rates for Automobile Traffic, when moved in NMG group, BCCNR and BCACM wagons are governed by Rates Circular No.32 of 2021 dated 30.11.2021, as amended from time to time.
2. The freight rates for Automobile Traffic, when moved in BCACM wagons are available at Annexure to Rates Circular No.32 of 2021.
3. The issue for separate rates for BCACM wagons, when automobile traffic is loaded in single stack, has been examined. Sanction of the Competent Authority is hereby accorded for notifying separate freight rates for automobile traffic when loaded in single stack in BCACM wagons. The Rates have been mentioned in Annexure to this letter,
4. Freight rates for automobile traffic when loaded in BCACM in double stack will continue to be governed by the Rates Circular No.32 of 2021, as amended from time to time.
5. Accordingly, the freight rates for single stack & double stack loading in BCACM wagons are enclosed herewith as Annexure.
6. All other terms and conditions mentioned in above referred Rates Circular and its corrigenda shall remain same.
7. This shall come into force w.e.f. 01.02.2024 and shall remain valid till 31.05.2024
8. This issues in consultation with Freight Marketing, Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.


