1.0. In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/ certified for 25 Tonne axle load on various notified routes.


2.0 . The routes are notified in terms of Annexure-IV of reference (iii) above.

3.0. Matter has been examined, in the light of South Eastern Railway's proposal, the Competent Authority has approved to add following routes, subject to operation of 25 ton axle load at 45 kmph from track point of view, in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:


- i. Garhhrubeshwar(GRB)-Adra(ADRA)/06.72km;
- ii. Muri(MURI)-Barkakana(BRKA)/57.84km;
- iii. Madhukunda(MDKD)-Radhangar(RDR)/10.31km; and
- iv. Bokaro Steel City(BKSC)-Pvt.Siding of M/s Dalmia Cement(Bharat) Ltd.(PBJT)/09.51km.

4.0. Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.

5.0. These instructions shall come into effect from 03.02.2024 and shall remain valid till further advice.




