



1. Please refer to Board's Rates Circular No.03 of 2022 cited under reference, wherein for the purpose of Charging of Truck Mixer, the same was classified at Class LR3 as Motor vehicles under Group No.25(m) of the Goods Tariff No.49 Part I, (VoL.II) w.e.f. 18.02.2022 till 17.02.2023.
2. The same classification was extended in terms of corrigendum no. 01 to Rates Circular No. 03 of 2022, dated 13.02.2023 till 17.02.2024.


