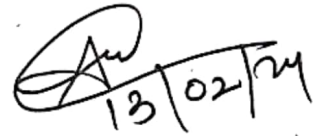

Sub: Amendment No. 1 to Master Circular on 'Gati Shakti Multi-modal Cargo Terminal (GCT)/2022/0 dated 06.12.2022'.

Ref: Master Circular on GCT/2022/0 issued vide Board's letter No. 2021/TC(FM)/18/23 dated 06.12.2022.

The policy guidelines on "Gati Shakti Multi Modal Cargo Terminal (GCT)" were issued to Zonal Railways vide FM Master Circular/GCT/2021 under Board's letter No. 2021/TC(FM)/18/23 dated 06.12.2022.

2. Board is in receipt of various suggestions with respect to the provisions of GCT Master Circular 2022, which have been examined in this office and accordingly it has been decided to amend/insert following paras in this Policy.

Para 9 of Schedule '2' of Policy "Bidders will be required to quote the percentage of Terminal Charges and Terminal Access Charges which they will claim from the Railway for all the traffic handled at the Terminal. Eligible bidder asking for the minimum share of Terminal share of Terminal Charges and Terminal Access Charges will be awarded the contract".	Para 9 of Schedule '2' of Policy Bidders shall quote the percentage of the share of Terminal Charge/Terminal Access Charge (TC/TAC) that will be retained by Railways – (A) If bidder quotes between 0 to 100% (say x%) it implies that Railways shall pay (100-x)% of TC/ TAC to contractor. (B) If bidder quote more than 100% (say y%) it implies that Railway will retain 100% charges and moreover bidder shall pay (y-100)% of TC / TAC over and above TC/TAC retained by Railway. Eligible bidders giving maximum share of Terminal Charges/Terminal Access Charges will be awarded the contract.

3. The above amendments shall be applicable on all GCTs i.e. already commissioned or going to commission after issuance of these amendments. In view of the above modification, necessary changes may be made by the Zonal Railways in the GCT Agreement as well as other documents wherever required.
4. This issues in consultation with Rates, Traffic Transportation, Civil Engineering, Signal & Telecom and Gati Shakti directorates, and with the concurrence of Finance(Comml.) Directorate of Ministry of Railways.

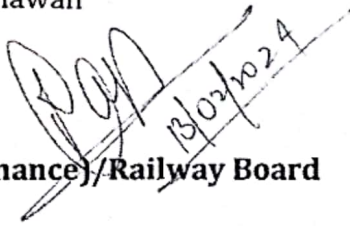
