






















**GOOD WORK DONE BY RPF/ECOR FOR THE PERIOD FROM 01.01.2024 TO 31.01.2024.**

1. On 03.01.2024, on the basis of PRABAL input officers & staff of RPF/Post/Jajpur Keonjhar Road arrested one tout (IRCTC Agent) viz. Maheswar Panda @ Hari, age- 36 yrs with seizure of 01 future Railway e-ticket valued Rs.388.40 & 48 nos. of past Railway e-ticket valued Rs.57,311.92 and detected 02 fake user IDs. RPF Post Jajpur Keonjhar Road case No-C3C/02/2024, dtd.03.01.2024 U/S 143 Railway Act. 
2. On 04-01-2024, on duty staff of RPF/Post/Jajpur Keonjhar Road retrieved 02 left behind luggage containing gold ornaments, laptop & clothes total worth Rs.2,00,000/- from T/No-12704 Faluknama Exp. at Jajpur Keonjhar Road station. 11. On 09.01.2024, on the basis of PRABAL input, officers & staff of RPF/Post/Srikakulam arrested one tout (IRCTC Agent) viz. Poothi Divakar Reddy, 30 yrs with 01 future e-ticket & 04 past Railway e-tickets. RPF/Post/Srikakulam registered a case vide no. C3C/19/2024, dtd-09.01.2024 U/S 143 Rly Act.

On 10.01.2024, acting upon a Rail Madad complaint officer and staff of RPF/Post/Duvada retrieved a left behind laptop bag valued Rs.65,000/- from coach No. B/5 berth No.19 of T/No. 18520 LTT-VSKP Exp.
