Commercial Circular No. 58(G) /2024

Sub: Temporary Permission for loading of 4 BOXN rakes of M/s MSPL Ltd. under Own Your Wagon Scheme over East Coast Railway.

Ref:- (i) Railway Board's letter No.2000/TC(FM)/4/3pt. dtd.13.04.2022, 06.05.2022 & 08.11.2023.
(ii) PCCM/ECOR's Commercial Circular No.383(G)/2022 Dtd.02.12.2022.

Railway Board vide letter dated 13.04.2022 under reference (i), have accorded sanction for temporary transfer of four (04) BOXN rakes of M/s MSPL Ltd. from SWR to ECoR initially for a period of 1 year with loading points at GADH, PRNR & NYG and unloading point at DPCB over ECoR which was valid up to 12.04.2023. Accordingly, Commercial circular under reference (ii) was issued. Railway Board vide letter dated 08.11.2023 have accorded extension of temporary transfer of the above 04 rakes from SWR to ECoR for one more year. In pursuant to the above order, the following instructions are hereby issued.


1. M/s MSPL Ltd. has procured 04 BOXN rake under Own Your Wagon Scheme (OYWS) and executed agreements dated 02.03.2007 with Chief Commercial Manager (FM), South Western Railway. In pursuant to Railway Board's order vide letters under reference (i), permission is hereby granted for loading of 04 BOXN rakes over ECoR for a temporary period of **1 year from 21.02.2024 to 20.02.2025**.
2. The loading and unloading points for the 04 rakes are as under.

| Loading | Unloading | Via |

3. Since, the subject 04 rakes have already been merged in the general pool of wagons of IR, Railway will make efforts to provide guaranteed 5 nos. of BOXN type rakes against each rake of M/s MSPL Ltd. per month. Thus, this railway shall make efforts to supply in total 20 rakes against the said 04 rakes from 3 loading points i.e. GADH, PRNR and NYG to DPCB for loading of iron ore against indents placed by M/s MSPL Ltd.
4. No upfront rebate or concession on freight is admissible under the scheme while issuing RR. Admissible lease charges against the rakes payable to the customer are to be reconciled at HQ level.
5. Record of the indents placed and rakes allotted to M/s MSPL Ltd. at all the loading points mentioned above is to be maintained. Division to monitor and collect the position of indents, allotment of rakes & loading details and submit the same to HQ on monthly basis.
6. In the event of failure of Railway to provide guaranteed 20 rakes per month in total from 3 loading points mentioned above, the shortfall may not be made good in the following month. For such shortfall in supply of rakes, Indian Railways will not be liable to pay any penalty to the lessor.

All concerned to note and act accordingly.
