


- 1.0. In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/certified for 25 Tonne axle load on various notified routes.
- 2.0 The routes are notified in terms of Annexure-IV of reference (iii) above.
- 3.0 Matter has been examined, in the light of East Coast Railway's proposal, and the Competent Authority has approved to add, in the list of 25 Tonne axle load routes, the following routes:
 1. From Budhapank CSB Km. 485.130(Take-off Point CH:486.193 Km. to Kamalanga CSB Km. 491.914 stations (Route-A) under Angul-Sukinda project covering a length of 6.784 Kms.
 2. From Block Cabin "A" of Tomka Y-Connection CH.89.100 km. to Block Cabin "B" of Tomka Y- Connection CH.92.947 km. under Angul-Sukinda project covering a length of 3.847 Kms.
 3. From Talcher Road Jn. CSB Km. 492.116 (Take -off Point CH.493.889 Km.) to Kamalanga Jn. CSB Km. 499.577 stations (Route-B) under Angul-Sukinda project covering a length of 7.461 Kms.
- 4.0 Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.
- 5.0 These instructions shall come into effect from 22.02.2024 and shall remain valid till further advice.


