Flux & Ferro Alloy, Cement, MS Slab, Iron Pellets, Pig iron, Hot Briquetted Iron, Slag, Bentonite and Clinker.
- ii) Outward- Steel, Slag, Pig iron, Granshots, Iron scrap, Lime Stone fines, Sponge Iron/DRI, Coal and coke, Iron ore Pellets, Iron ore fines, Sinter, Coal Tar, Gasification oil, HR Coil, CR Coil, Cement and Clinker.
