





Please refer to Rates Circular No.22 of 2017 regarding Haulage Charge for running of Double Stack Dwarf Container. These guidelines are valid upto 31.03.2024 as per Corrigendum No.4 dt.31.03.2023 under reference (ii).

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Railway Board.




