Staff concerned may necessarily be informed well in advance about the written test to avoid complaints at a later date.

The Staff concerned should also be informed that there shall be no Supplementary Test under any circumstances except in certain valid reasons indicated in Para-223 of IREM-Vol.-I, 1989 Edition, which are genuine and acceptable by the competent authority. Cases of unwillingness/refusal, sickness or unauthorized absence or absence for reasons beyond control must be forthcoming before the date of written test.

However, immediately after completion of the written test, the reasons for absence or unwillingness etc of the candidates, if any, may be sent to this office for taking further course of action at this end.

Candidates should note that Mobile phone, bags, books/not books, any electronic gadgets, camera, Bluetooth etc are not allowed inside the examination halls. It is to be noted that the candidature of the candidates has been accepted provisionally. If any candidate is subsequently found ineligible at any stage of the selection, his/her candidature will be rejected without any further notice.

This provisional answer key will be published in the East Coast Railway Website for information of candidates who attended the written test for identifying any error in the answer key within 7 days of publication of answer key in the website. This provisional answer key along with one question paper will also be sent to evaluating officer for his remarks. Objections, if any received from the candidates/evaluating officer will be sent to the evaluating officer for necessary action. The decision of the question setter on the answer key will be final.
